

Compensation Plan

This page summarizes how affiliate commissions and payouts work at 2Be.vip. The **authoritative** rates, thresholds, and eligibility rules are the ones shown inside your affiliate back office (dashboard) at the time of each transaction. If there is any conflict, the Affiliate/Referral Program Terms and the dashboard data control.

1) Key definitions

- **Customer:** a user who purchases a product/subscription.
- **Affiliate / Member:** a registered referral program member with a unique referral link/code.
- **Qualifying Purchase:** a purchase that is eligible for commission (not cancelled, not reversed).
- **Commission Period:** the time window used to calculate commissions (e.g., weekly or monthly).

2) Eligibility to earn

- You must have an active affiliate account in good standing.
- You must comply with the Affiliate Terms and Marketing Guidelines.
- We may require identity verification and valid payout details before releasing payouts.

3) Commission types (structure)

The program may include one or more commission types. If a type is not offered, it will not appear in your dashboard.

- **Direct Referral Commission:** earned when a customer purchases through your referral link/code.
- **Team / Network Commission (if applicable):** earned based on qualifying purchases within your referral structure.
- **Performance Bonuses (if applicable):** earned when you hit defined targets or ranks.
- **Incentives / Promotions (if applicable):** limited-time incentives published by the company.

4) How commissions are calculated

- Commission is calculated on **qualifying** transactions only.

- Taxes, payment fees, discounts, refunds (if any), and reversals may affect the commissionable amount.
- We may delay finalizing commissions until the end of a **review/validation period** to detect fraud or payment reversals.

5) Payout schedule

Payouts are processed on the schedule published in your dashboard:

- **Commission period:** [e.g., monthly / weekly] (see dashboard)
- **Payout processing date:** [e.g., within X business days after period end]
- **Validation/hold period:** [e.g., X days] to handle chargebacks and fraud checks

6) Minimum payout and payout method

- **Minimum payout threshold:** [e.g., USD/ AED/ SAR X] (see dashboard)
- **Payout method:** [e.g., bank transfer / payment provider] (see dashboard)
- Payout fees (if any) may be deducted and will be shown before payout.

7) Chargebacks, reversals, and clawbacks

Even if a product is “no refund”, payment providers may still process chargebacks/ disputes. If a transaction is reversed, cancelled, found fraudulent, or otherwise becomes non-qualifying:

- Any related commissions may be reversed (“clawback”).
- If you have already been paid, we may deduct the reversed amount from future payouts.
- Repeated fraud or abuse may lead to suspension or termination.

8) Fraud and abuse controls

- No self-referrals or purchasing primarily to generate commissions (unless explicitly allowed in writing).
- No duplicate accounts, fake identities, or manipulation of the referral structure.
- No misleading marketing, spam, or prohibited claims.

9) Adjustments and plan updates

We may update the Compensation Plan from time to time. Changes will be posted and/or reflected in the dashboard. Changes apply prospectively unless required otherwise by law or to correct errors/fraud.
